



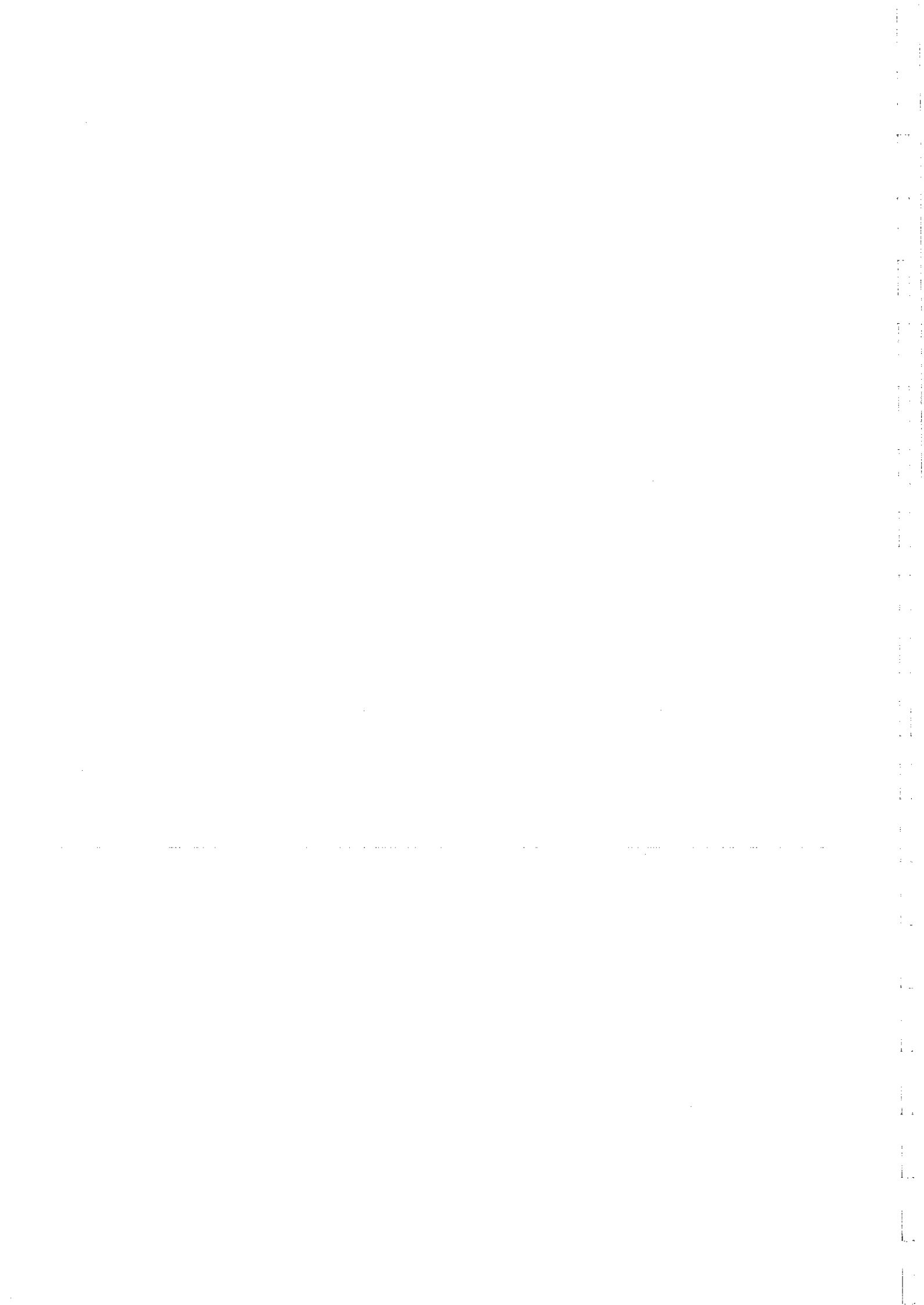
Dear Kieran Fennelly,

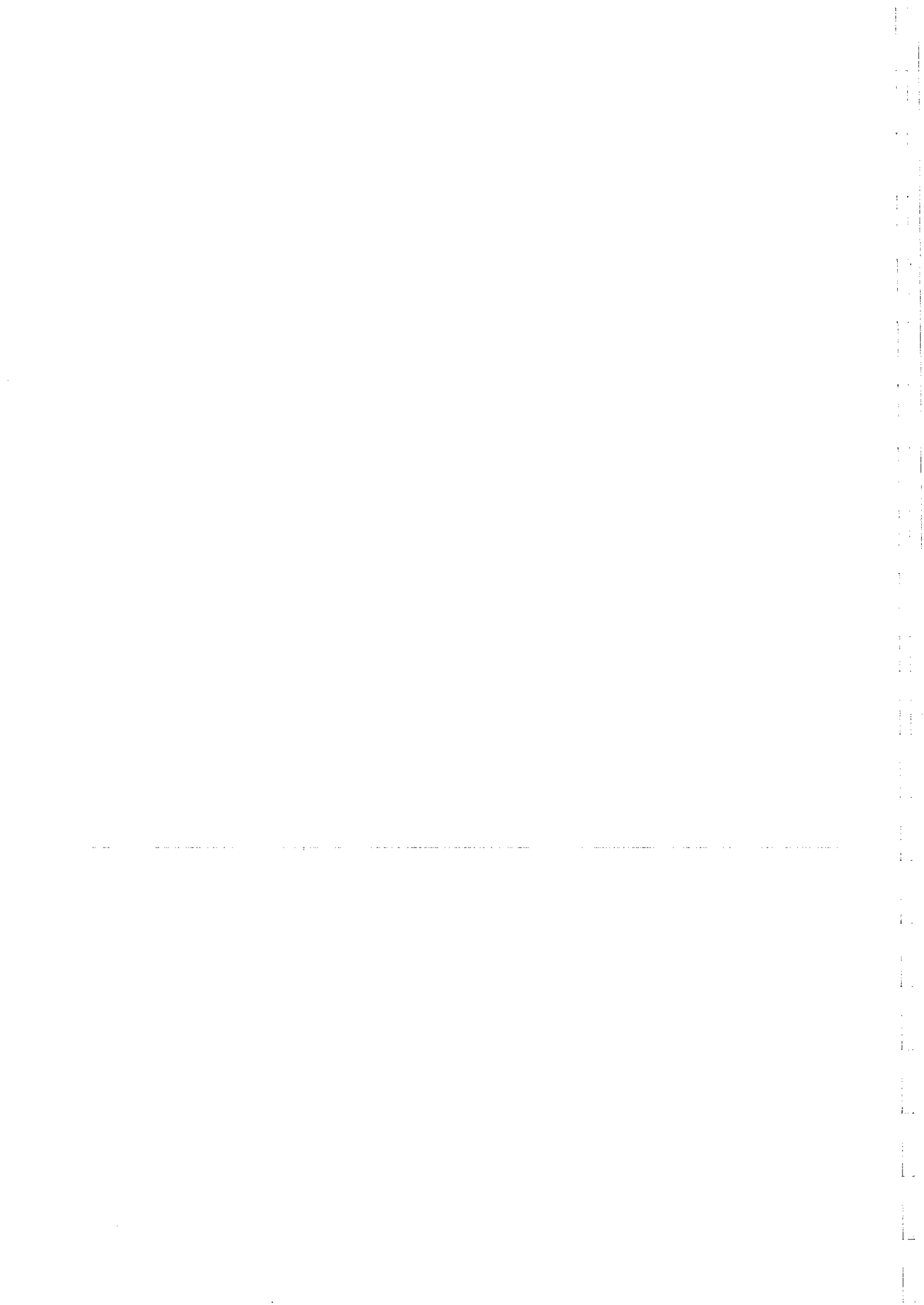
Statement of Appropriate Officer's Responsibilities

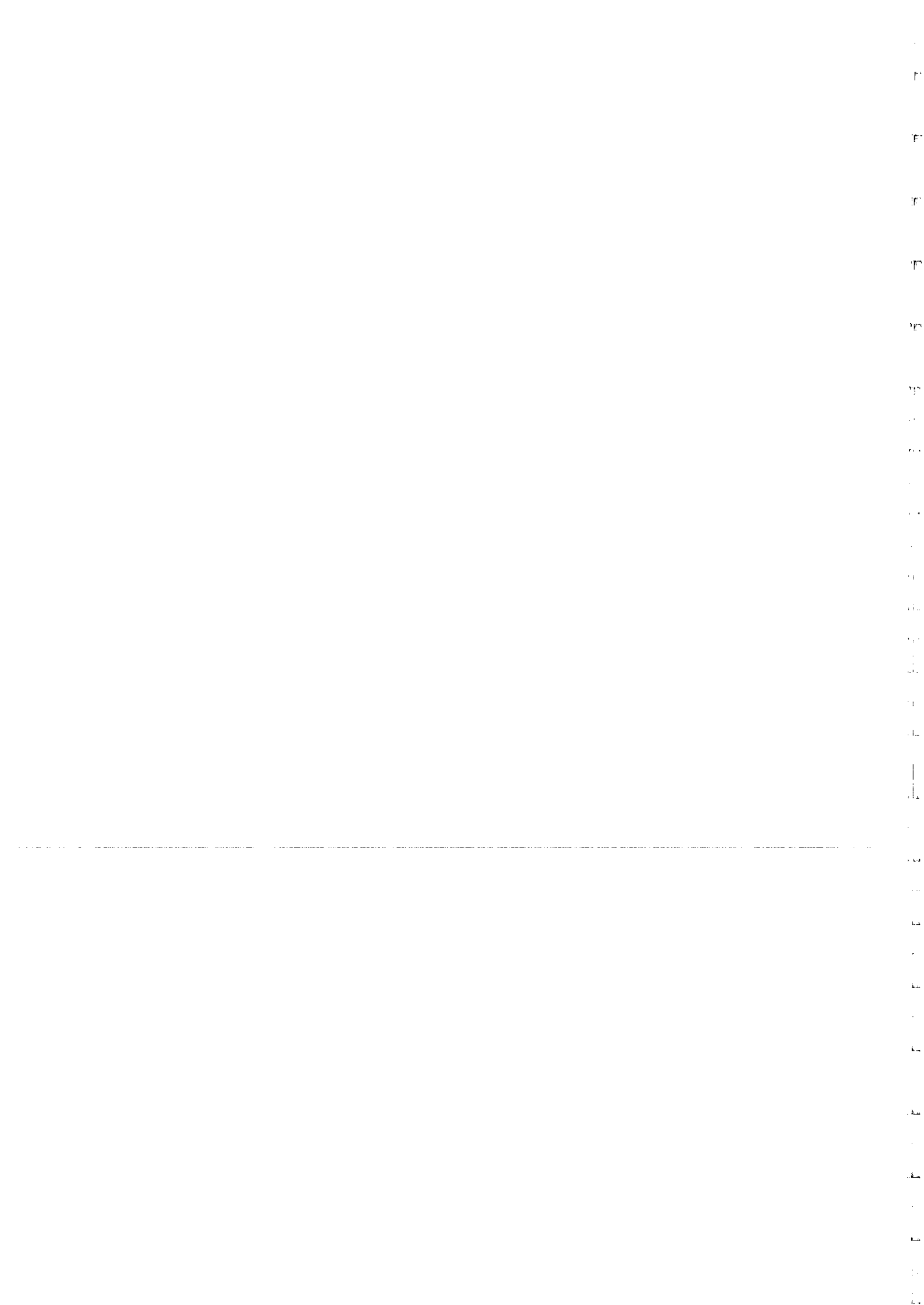

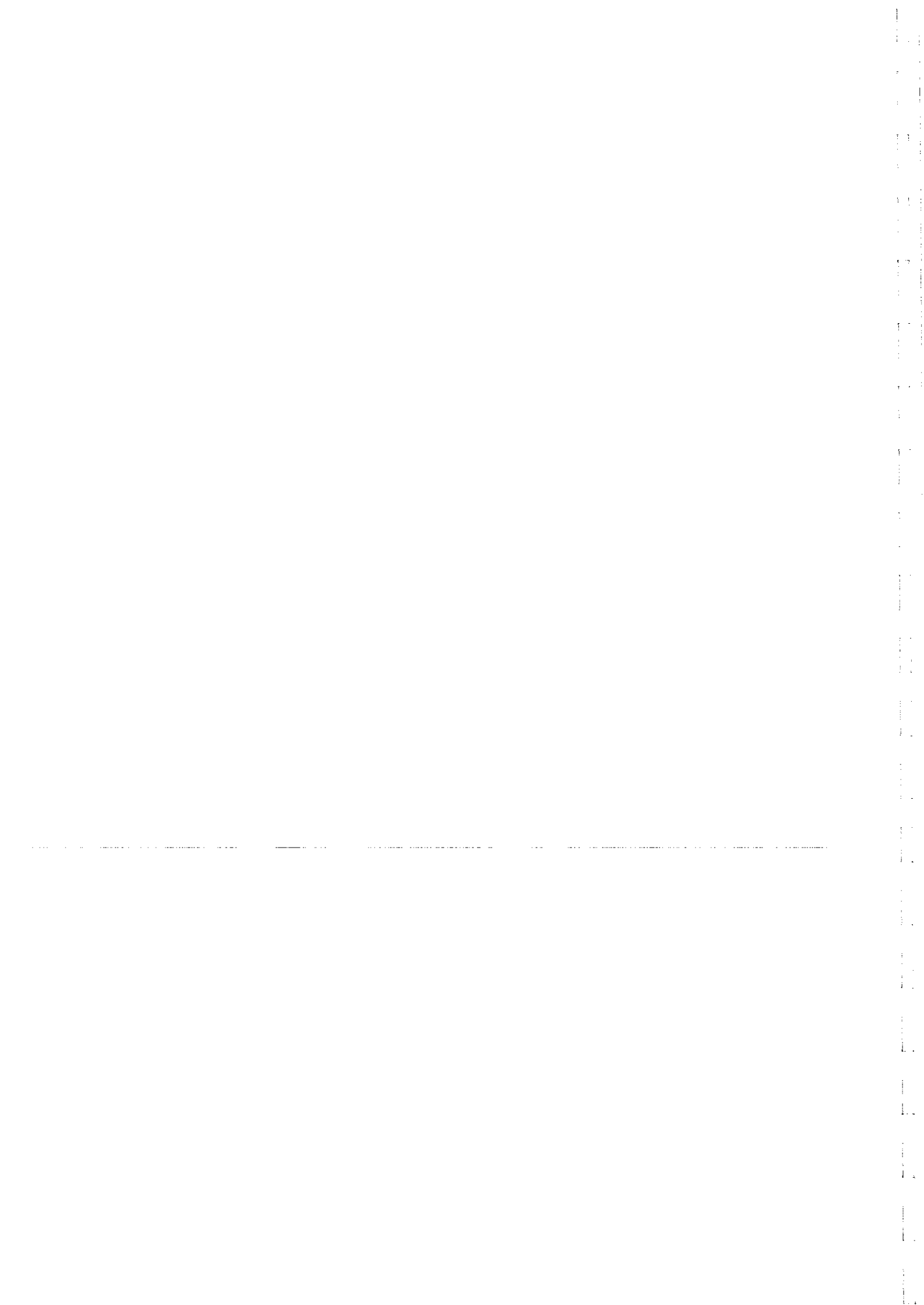

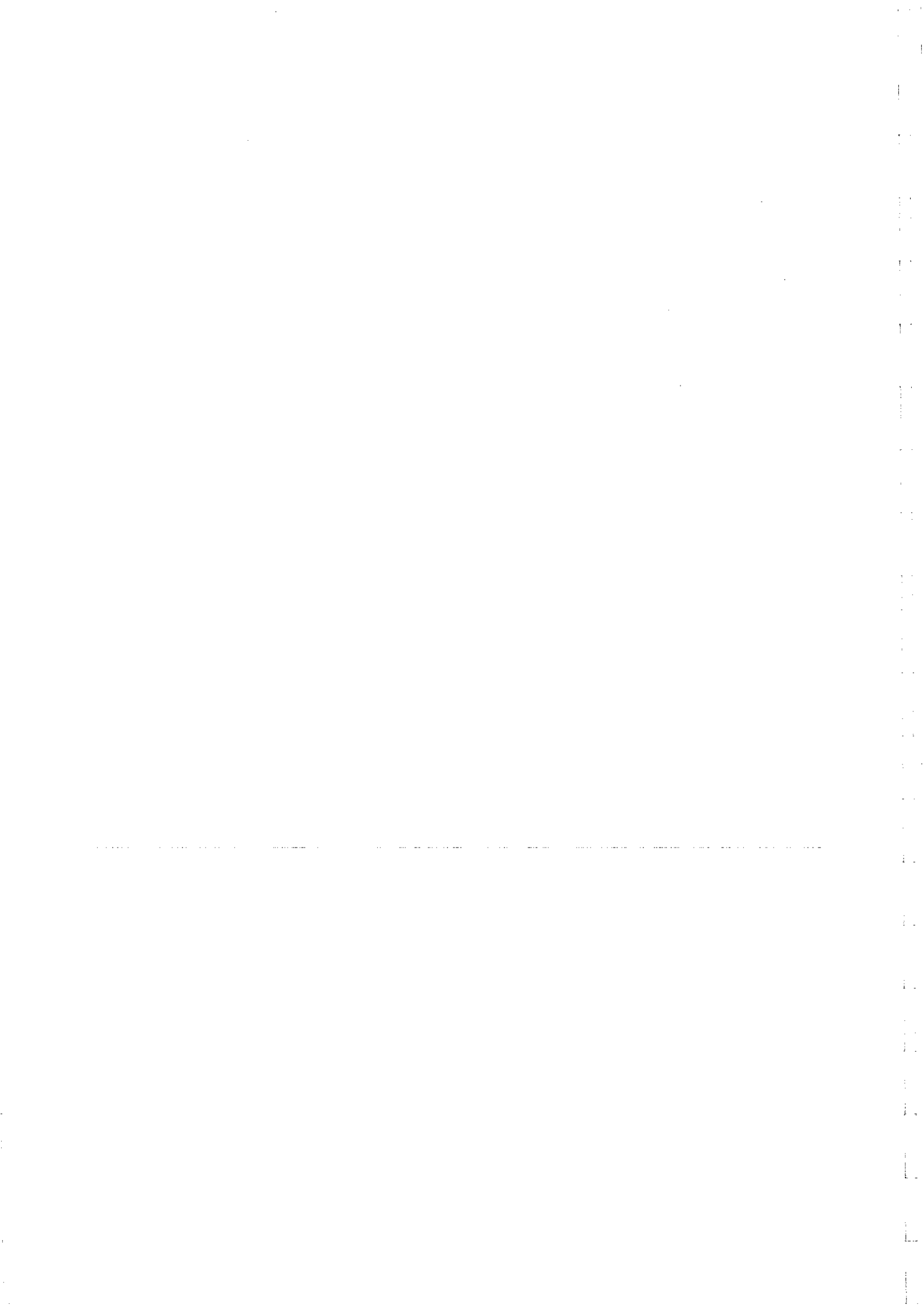
